Every report pulled from SafetyReports is branded, includes corrective actions, and is consistent — even for those who struggle with writing.

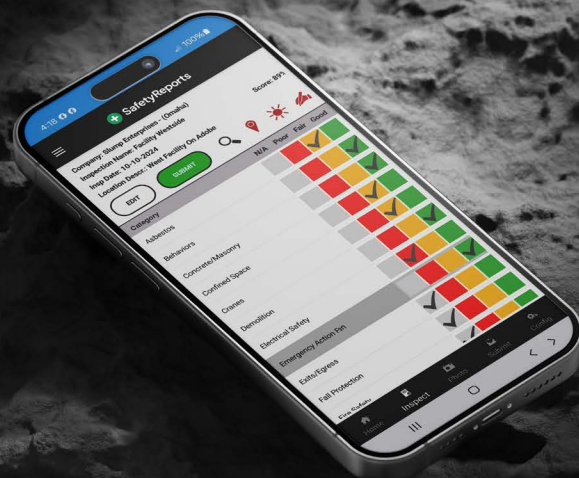
